If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry will be made.

Dogs may arrive any time prior to their scheduled time of judging. Dogs not required for further judging will be excused. **Judges will not wait for any dog holding up a class.** Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. **All dogs present must be held on leash** or confined to their crates except when being judged or when in the exercising pen. **No gasoline or diesel generators** are permitted within 100 feet of any tent in which this dog show is conducted

The AWSC, the Show Superintendent, the property owners, employees and any agent and/or members associated with the show will not assume responsibility for any loss, damage, or injury sustained to exhibitors, handlers and their family, guests or to any dogs or property. Parents are responsible for the control and safety of their children. All persons attending these shows hereby waive any claim for damages against the above in the event a motor vehicle has to be entered to rescue a dog(s) from overheating, improperly vented conditions, or any situation deemed to be an emergency by any of the Event Committee.
